Annotation: In this article, the areas of professional activity of a social worker are the social protection system, employment services at the national and regional levels, as well as local enterprises, institutions and organizations, governmental and non-governmental institutions, regional centers and social assistance. funds.

**Keywords:** employment, intangible products, physical endurance, social worker, legal protection, migration, crisis, stress, violence, unemployment, ethics, environment, family, education.

**Social Work** - This is a professional activity to help and support people, the goal of which is to help people and groups in difficult life situations overcome personal and social challenges by helping, protecting, correcting and rehabilitating them.

Modern social work is mainly carried out by a wide network of public social services. It covers many areas, for example: social security, social insurance, social prevention, social rehabilitation, adaptation, therapy, counseling.

**Social Work Specialist** - An employee who serves different social, gender and age groups, ethnic groups and individuals in need of social assistance, protection and psychological support.

The profession of "Social Work Specialist" has the following specialties: social worker, employment social worker, organizer of socio-legal cooperation, professional (in various fields) consultant. These workers may be specialized by age, gender, social and medical characteristics (specialized children and adolescents, the elderly, the unemployed, the homeless, the blind, the deaf, etc.).

Occupation type: means "man-to-man", which focuses on communication and interaction with people. It requires the ability to establish and maintain business relationships, to understand people and human relationships, to be active, open-minded and communicative, to develop speaking skills and verbal thinking, to have emotional stability.

An additional type of profession: "Man is nature" because it is concerned with caring for living people and preventing and treating diseases. This requires a high level of observation, attention, physical endurance, a willingness to work with people in need of help and care, and the development of interest.

What is the efficiency and purpose of the work (what is being done and for what purpose)? Purpose of work: products, services; the importance of the work: the value and importance of the products or services provided to the enterprise and the country as a whole.

The activities of the social work specialist include financial assistance and moral support to the disabled, lonely elderly, mothers with many children, orphans, the seriously ill, those prone to

A social work specialist not only achieves clearly defined goals and solves standard, typical tasks, but also faces problems in an infinite number of options that require a solution. Because the more people live in the country, the more diversity there is.

The main objectives of social work as a professional activity are as follows.

The independence of individuals, the growth of their ability to manage their lives and solve problems effectively;

Materials, raw materials, semi-finished products, intangible resources - information, written data and documents, financial, technical services, services - ancillary activities.

The social work specialist provides assistance to vulnerable segments of the population in need of social support, assistance, services and protection.

#### **Clients of social workers:**

children and youth: children left without parental care; children with special needs; Children living with HIV; children and youth at risk or against the law; students and graduates of children's institutions; Students and graduates of specialized educational and training institutions; street children; Children exposed to violence or neglect, witnesses of violence; children involved in traffic, the most severe forms of labor and exploitation; children affected by natural disasters, armed conflicts, etc .;

families and women: low-income families, families with many children, single parents, family members living with HIV, families with special needs, families in crisis (one of the members survival, divorce, conflict, domestic violence, migration, etc.). etc.); families affected by natural disasters, armed conflicts; foster families and adoptive parents, etc.; People with disabilities and their families; Lonely elderly people in need of social assistance;

People in difficult life situations: survivors of death or serious illness of loved ones, suffering from chronic diseases, loss of work, home and other things;

For successful professional development, a social work specialist needs general knowledge of social, humanitarian and ethical issues, basic knowledge of history, Russian language and social sciences.

Must know: basics of ethics, psychology, basics of medicine, basics of economics, legal norms<sup>[2]</sup>.

#### Must have a qualified social work specialist :

The main subject of labor is the person (social services), the system of signs that accompanies it (texts, documents).

In his work, the social worker uses material (weapons) means of labor - manual (pen, pencil), electrified (calculator, computer), as well as means of communication (telephone, fax).

But the main ones are its intangible (functional) means - analytical, verbal-logical thinking, long-term and operative memory, good distribution of attention; body movements, emotionally expressive speech and behavior, work writing, as well as the general compatibility of the senses -

Establishes close relationships with representatives of various organizations and institutions in need of client assistance, works closely and collaboratively with them (psychologists, lawyers, teachers, medical staff, social workers, law enforcement officers etc.);

Helps to involve various institutions of the society in the activities of social services and to create a network of social services that provide assistance and support to clients;

Helps the other person who is in a difficult life situation to be properly understood by other professions and representatives of the population;

Shares information with professionals involved in working with the client in a manner that respects privacy and its best interests;

Announces contentious issues that may lead to a conflict of interest;

Informs the management or relevant responsible structures about the opportunities or organizational difficulties that arise in the process of social assistance and support to different categories of the population.

**Requirements for professionally important qualities.** This position (in descending order of importance) lists the requirements for the qualities of an employee of professional activity.

In this case, the concept of "quality" has a generalized nature and refers not only to personal characteristics, such as responsibility or advanced organizational skills, but also to a person's special abilities, general abilities and psychophysiological characteristics and characteristics of his nervous system. To be successful as a social worker, the following important qualities are required:

Considering the essence of the social policy pursued in our country, at the heart of all the work carried out for citizens is the goal of ensuring social welfare and economic stability, creating opportunities for them to lead an active life.<sup>2</sup>.

In this context, legal and economic knowledge are of paramount importance in the context of knowledge as a social worker implementing social policy.

In particular, who is the client of the specialist? - This is a person who finds it difficult to solve his problems, a person who is in a difficult situation in life. Observations show that its problem is often related to economic and legal issues. The person who wants to help him should not need help in the first place. He must know the legal norms in finding a solution to the problem, be able to conduct the necessary economic analysis, have sufficient skills to overcome various bureaucratic obstacles in attracting the state social security system.

To do this, in the system of training in the field of social work in our country it is necessary to abandon the traditional methods of teaching - theory + practice and use a new form - practice + theory.
