#### Introduction

In our country, significant reforms are being carried out in the field of ensuring equal participation of women and men in the management of public affairs, the electoral process, as well as ensuring guarantees of equality of their rights and opportunities in health care, education, science, culture, labor and social protection, as well as in others, areas of public life. The content of the reforms can be seen in the priority areas of gender policy aimed at ensuring equality between women and men and the expansion I their participation in public life.

In his speech at the 75th session of the UN General Assembly, the President of the Republic of Uzbekistan Shavkat Mirziyoyev noted that the policy of gender equality has become a priority for us, the role of women in public administration has increased, and the number of women deputies in our new Parliament has doubled.

It should be noted that today the share of women in leadership positions has reached 26.6 percent, and in the last elections for the first time in the country, the share of women elected to the Legislative Chamber of the Oliy Majlis of the Republic of Uzbekistan was 32%, while in the Senate and local Kengashes this indicator amounted to 25 percent.

To date, a legal basis has been created to ensure the implementation of the gender policy of our state and the Laws of the Republic of Uzbekistan " On guarantees of equal rights and opportunities for women and men " , " On the protection of women from oppression and violence " , as well as the Resolution of the President of the Republic of Uzbekistan " On measures to further strengthening of guarantees of labor rights and support of entrepreneurial activity of women " from among them.

In particular, in accordance with this decree of the President of the Republic of Uzbekistan, the Commission for Ensuring Gender Equality of the Republic of Uzbekistan was created, one of the main tasks of which is to ensure gender equality in the country and to actively participate in the implementation of state policy aimed at improving the social living conditions of women.

#### Main part

At a meeting of the commission held 21<sup>st</sup> December last year as an example of s progress in promoting gender equality, improving socio-political activity of women and their full support, it was noted that over the past period 950 girls in need of social protection have been adopted in the study, 166, 3 thousand women were employed for permanent work, 31.1 thousand were trained in the profession, 48.4 thousand unemployed women received unemployment benefits and were admitted to social protection, in each region, "Women's Entrepreneurship Centers" were created and preferential loans were allocated by appropriate trust funds and commercial banks, for the development of entrepreneurship, more than 224 thousand women received preferential loans totaling 6.9 trillion soums, a "Women's Book" was created for targeted work with unemployed women, and the housing conditions of 1 thousand 40 women in difficult social situations were improved.

Along with the results achieved, at the meeting of the Commission on Ensuring Gender Equality of the Republic of Uzbekistan, the negative situations in this area were also discussed and it was noted that 11 thousand 138 women who were subjected to various forms of assault and violence were issued protection orders, of which 9 thousand 916, i.e. 89 percent were subjected to domestic violence, 5 thousand 418 suffered physical violence, leaving 652 families were divorced.

In order to overcome the systemic problems of gender equality, to ensure equal rights and opportunities for women and men in every area in the State Program for the implementation of the strategy of action in five priority areas of development of the Republic of Uzbekistan in 2017-2021 in the "Year of Supporting Youth and Strengthening the Health of the Population »Appropriate measures have also been identified.

#### Results

In paragraph 19 of the State Program envisages the development of a strategy for achieving gender equality in the Republic of Uzbekistan till 2030, and in the relevant draft normative act defined issues such as ensuring equal 's right and opportunity to her women and men in the implementation of the electoral law, public service areas education, science, health and others, in the prevention of harassment and violence in the Family 's relationship and bring-up and children to her.

Also, in that paragraph of the Program provides for the development program of a set of measures and targets for improving the conduct of gender statistics on the gender mainstreaming strategy in the Republic of Uzbekistan and the implementation of C strategies are achievements Nia gender equality in 2021 - 2023 years.

#### Conclusion

In conclusion, it should be noted that the above reforms and the Strategy for Achieving Gender Equality are important for achieving real equality between women and men in our country, expanding the participation of women in all spheres of society, eliminating and preventing direct and indirect gender discrimination.
